**WHEREAS, a proper petition was filed with the Town of Reidville on June 12, 2006 by at least 75 percent of the freeholders owning at least 75 percent of the assessed value of the property hereinafter described, which property is contiguous to the Town of Reidville, requesting annexation of the property to the Town of Reidville under the provisions of S.C. Code Section 5-3-150(1); and**

**WHEREAS, it appears to Council that annexation would be in the best interest of the property owners and the Town of Reidville; and**

**WHEREAS, the notice, public hearing and other requirements of S.C. Code § 5-3-150 have been complied with;**

**The territory to be annexed is described on the map hereto as Exhibit A and is made part hereof by references as description to follow with all tax map numbers of the properties to be annexed.**
